# RULES FOR ADMISSION INTO THE CUTTACK TRAINING COLLEGE. Session, 1937-38.

1. Applications are invited from candidates for admission into the Cuttack Training College for the session 1937-38.

2. The college prepares students for the Diploma-in-Education Examination of the Patna University. A degree of an Indian or any other recognised university is the minimum entrance qualification.

3. Number of admissions is limited to 22. Of these, 2 will be from the Orissa States on the nomination of the Educational Adviser, Eastern States Agency. All applicants must be natives of, or domiciled in, Orissa. Five (5) will receive stipends of Rs. 20 a month each. Each of the other fifteen (15) non-stipendiaries will be provided with a set or text-books not exceeding Rs. 50 in value, which must be returned to the college in good condition, at the end of the session.

4. All applicants shall be required to take a qualifying examination which will be held in the college on the 14th April 1937 at 7 A.M. No admission will be made without a personal interview. Applications from such candidates as are over 31 years may not be considered. Each applicant must send Rs 5 being caution money and annas four towards charges, etc., for the entrance examination along with his application and obtain from the college office in lieu of the payment of Rs. 5-4-0 his admit card. Without this amount his application will not be accepted and his name will not be enlisted. No candidate will be allowed to sit for the examination unless he has shown his admit card to the presiding officer. In their own interests, candidates are warned to be in possession of admit cards before the date of the examination. Only papers will be supplied to candidates who will sit for the examination. Candidates are allowed to write out their answers with a pencil or with their fountain pen. The caution money will be forfeited if a candidate fails to join after admission or withdraws at any time during the session. The money will be refunded in case admission is not granted and in case of those who are admitted at the end of the session. A candidate claiming domicile in Orissa, must submit copy of his certificate of domicile along with his application and on admission the original. Degree certificates must be produced by all candidates for inspection by the Principal on the date of admission.

5. If a candidate does not join within a week of his being informed that he has been accepted, his admission will be cancelled and his caution money forfeited.

6. Each selected stipendiary candidate will be required to enter into an agreement in the prescribed form, binding him to complete the course of training to the satisfaction of the Principal and thereafter to serve either as a teacher in a Government school or as a Sub-Inspector of Schools. If he withdraws before completing the course he will have to refund the stipend drawn by him. No permission will be given to candidates admitted for private tuition and study of law during the course of training.

7. Such candidates as do not belong to the University of Patna and graduated from any other university, must also pay at the time of admission, the registration and migration fees levied by and payable to both the universities.

8. All college charges must be paid at the time of admission, viz., the game fee and the common room fee which are respectively Rs. 3 and Rs. 2 for the session.

9. In applying for admission, candidates should supply the following particulars :---

- (k) Testimonial, if any, from the principal of the college at which he last studied.
- (l) Whether the candidate is willing to join as a non-stipendiary candidate if he does not qualify for a stipend.
- (m) Age on the 1st July 1937.
- (n) Present address.
- (o) Signature of the candidate with date of application.

# RULES FOR ADMISSION INTO THE CUTTACK TRAINING SCHOOL.

#### SESSION 1937-39.

Twenty Oriya-speaking stipendiary candidates from the British Orissa and nonstipendiary candidates including 2 candidates from the Orissa States will be admitted to the first year class of the Cuttack Training School on the 1st July 1937. If-candidates from the British districts be not forthcoming for the eight non-stipendiary seats which are normally available for them, candidates from the Orissa States may be taken in, to fill up the seats.

2. Only those should apply (a) who are of good physique, of active habits and free from any constitutional defects, (b) who are prepared to take active interest in drill, games, gardening and scouting and (c) who are proficient in Oriya literature All candidates must be native of, or domiciled in the province of Orissa.

3. The candidates with Matriculation or School-leaving Examination certificates should submit with their applications certified copies of the marks secured by them at the examination.

4. The length of the course for the Teachers' Certificate is two years. Admission will be confined to the candidates with intermediate qualification, matriculates and holders of the high school-leaving certificates. Preference will be given to those who pass in high divisions provided they satisfy all other conditions.

5. Intending candidates are required to appear at the test examination for admission which will be held in the Training School on the 1st July 1937. They should come provided with writing materials.

6. Students who have passed the Intermediate, Matriculation or School-leaving certificate examination and will reside in the hostel will get a monthly stipend of Rs. 8 only.

• 7. Before admission into the school the selected candidate will be required (i) to produce his transfer certificate from the institution in which the candidate last read, (ii) to execute an agreement binding him to complete the prescribed course, to abide by the school rules and on completion of the course to serve as a teacher in the province of Orissa for at least three years, if required to do so, and if offered a post of an initial salary cf not less than that from time to time prescribed by Government as the minimum pay for teachers of his qualifications in the class of schools concerned. Those who will give up their study before the expiry of their full training period will be liable to refund all the money received by them as advance or stipend.

8. Holders of the Teacher's Certificate are recognised by the department as qualified for any post except headmastership of Middle English School for which untrained teachers with intermediate qualifications are eligible, and if appointed to the Vernacular Teachers' Service will draw pay in the following scale or any other scale prescribed by the Government of Orissa :--

- For trained matriculates Rs. 35-1-50 with a selection grade on Rs. 55.
- (2) For trained men with intermediate qualifications Rs. 45-1-50 with the above selection grade.

9. Trained Matrics or S.L.C's are allowed to appear at the I. A. Examination of the Patna University after serving for one year as a teacher in a recognised school of the province.

#### MEMORANDUM I

FOR

#### THE CONDUCT OF THE TEACHERS' CERTIFICATE EXAMINATION, 1937.

The Teachers' Certificate Examination of the Secondary Training School, Cuttack, will be held on Tuesday, the 20th April 1937, and the following days from 7 to 10 A. M. in the order mentioned below:---

Each theoretical paper is of three hours duration. The Nature Diary is credited with 25 marks. Aboriginal candidates are only required to obtain 30 per cent of the marks in the First Vernacular.

2. The Headmaster will submit the Nature Diaries to the examiner at least two weeks before the examination and the examiner will send back the diaries to the school not later than the 1st May 1937 after valuing them and drawing up his report about the work done in the school for the consideration of the Board and the Inspecting Officer.

3. The practical portion of the examination may be held before or after the theoretical examination. The exact dates for the centre will be fixed by the examiner concerned and communicated to the Headmaster of the Training School and the District Inspectors of Schools. The latter will inform the private candidates of their districts regarding the dates of the practical examination.

The maximum marks assigned for the practical examination are 500, of which 100 are for correct pronunciation and clear enunciation, 75 for blackboard work, 75 for hand-made teaching devices and 250 for general teaching skill. The marks reserved for hand-made teaching devices should be allotted to an examination in the subject held at the time. In case of failures of regular candidates their work done during their stay at school should also be taken into consideration. The private candidates must bring with them exhibits made in accordance with handwork syllabus for Secondary Training Schoels (certified by some responsible person to be their own work) and will be required to prepare any of them at the time of the examination. In order to pass the practical examination a candidate must obtain 40 per cent of the maximum marks assigned. Candidates obtaining not less than 900 marks are placed in the first division, candidates obtaining not less than 675 marks are placed in the second division, and other successful candidates in the third division. A candidate who obtains 70 per cent of the marks in any of the eight theoretical groups or in the practical examination as a whole is declared to have passed with distinction in that group or that part of the examination, as the case may be. The result of the practical examination should reach this office, on or before the 15th May 1937.

4. In case of regular candidates the final marks in drill, gymnastic, games, gardening manual work, hand-made apparatus and music will be awarded by the controlling officer of the school and submitted to this office, on or before the 15th May 1937.

5. The Headmaster of the Cuttack Training School will be the Superintendent of the examination.

6. Four weeks from the date of the examination shall be granted to examiners for submitting marks provided that when an examiner has not more than a hundred papers to examine, the time allowed shall be *two weeks*.

The examiners are requested to be particularly careful to send all marks within the prescribed time. Defaulters are reported to the Board.

7. Examiners are requested to notify to this office along with the last batch of marks the number of answer books they have examined and to submit a short report on the quality of work done by the candidates. The report shall give a statement showing the percentage of passes and embody such remarks and recommendations suggested by the work done by the candidates as the examiner thinks it desirable in the interest of education to communicate to the head of the school. It shall be of a perfectly general character, dealing with the quality of work as a whole, and while embodying concrete and positive suggestions for the improvement of the answers of the candidates and drawing attentiou to the most frequent errors, it should not ordinarily contain criticisms of the work or the results of the school.

3. The examiners will send to the undersigned the answer papers soon after the results are published and a bill (not more than one) of contingent charges with proper vouchers for every item included therein.

If in case of a particular item of expenditure it is not possible to obtain a voucher the examiner should submit a certificate in the form which will be supplied from this office on requisition.

9. The question papers will be sent by this office to the Superintendent of the centre in scaled covers with the name of the examination, subject and the number of papers in the cover superscribed. If the Superintendent does not receive the question papers a week before the commencement of the examination, he should immediately inform this office.

10. With the necessary question papers despatched to the Superintendent there will be sent a packet containing one copy of each of the papers set for the examination whether or not those papers appear to be required at the centre. If no copy of the paper which is required is found to have been sent, this 'emergency packet' should be opened and the necessary paper should be taken out, the packet being at once re-sealed by the officer in charge; otherwise the packet should be returned unopened to the undersigned at the close of the examination. If the packet is so opened the reason should be stated.

11. The Superintendent as soon as he receives the cloth bundle containing the question papers, will open it and compare the number of question papers and the name of the subjects noted on the separate scaled covers contained in the bundle, with the indent sheet. If any difference is found between the two he will at once inform this office. The scaled covers containing the question papers are in no case to be opened before the time of examination.

12. The Superintendents will please mark attendance of the candidates for each paper and send the attendance sheet to this office at the end of the exmination.

13. The Superintendents will please see that the candidates are seated sufficiently apart to prevent copying.

A plan of the arrangement of seats will be prepared on a scale and will be sent with the attendance sheet to this office.

14. The Superintendent will despatch the answer papers per registered parcel, service paid, direct to the examiners together with a copy of the question paper as soon as the examination in each paper is over, arranging them separately for separate examiners and in the order in which the names of the candidates appear in the descriptive-rolls to be supplied to him by this effice. He will also send a statement, in the form C supplied, detailing the number of answer papers sent and the ab-entees. The examiners too will send to the Superintendent and the undersigned a similar statement on the receipt of the answer papers.

15. All officers concerned with the examination arc requested to duly report to this office any change in their addresses.

16. Answer books, blotting paper and ink will be supplied by the Superintendent to the candidates.

17. Candidates using or trying to use unfair means of any sort will at once be expelled from the examination and an immediate report will be made to the undersigned by the Superintendent. In no case shall such a candidate be allowed to appear at the remaining parts of the examination. Candidates thus expelled may be debarred from the future examinations of the Board.
