

GOVERNMENT TRAINING SCHOOLS IN THE GANJAM DISTRICT PLAINS.

The District Educational Officer, Ganjam, hereby notifies for the information of intending candidates for teachers' training, managers of aided schools, president, district board, chairmen of municipal councils, presidents of village panchayat boards, the District Labour Officer and Deputy Inspectors of Schools in the district, that candidates for training in the secondary grade, elementary higher and lower grades, will be admitted in July 1937 in the Government Training Schools as noted below:—

2. The rate of Provincial stipends for the higher and lower grades are Rs. 6 and Rs. 5 respectively. There are no stipends for the secondary grade.

3. Persons who have passed the Secondary School Leaving Certificate Examination or have obtained 35 per cent of marks in all the subjects will be considered as qualified for admission into the secondary grade; those who have passed the third form of a recognized secondary school or have been granted Elementary School Leaving Certificates of the VIII standard marked at least 'fair' will be considered qualified for admission to the higher grade and those who have passed the late primary examination or obtained Elementary School Leaving Certificates of the V standard marked 'fair' or a Sessional School Leaving Certificate, qualifying the holder to teach up to the old IV standard or the new V standard will be considered fit for admission into the lower elementary grade. Holders of North Orissa certificates corresponding to the above qualifications in each grade are also eligible. Preference will be given to those candidates whose educational qualifications are above the minima fixed.

4. Teachers possessing less than one year's service should not be recommended and their names should not be included in the list; teachers having more than one year's service and whe were rejected for other reasons (specified) should be included in the list; elementary lower grade teachers who have joined the Educational Department after 12th January 1932 are not eligible for admission. The Deputy Inspectors of Schools should certify that they have not recommended any such teachers. Separate lists should be submitted in respect of holders of Puri certificates.

5. Some teachers complain that their names are not shown either in the recommended or rejected lists even though they have submitted their applications in time. The Deputy Inspectors are requested to show the names of all untrained teachers who satisfy the conditions in the lists submitted by them. A separate list of untrained teachers working in the ranges as it stood on 1st April 1937 should be submitted noting therein the date of entertainment in the case of those that have joined in service after 12th January 1932.

6. All applications for training should be submitted in the prescribed form, through the managers of schools in which the applicants are employed, to the Deputy Inspectors of Schools of the ranges together with the copies of the general educational certificates on or before the 30th April 1937. Applications received after the prescribed date and those submitted direct to the District Educational Officer will be rejected. Original certificates should not be submitted with the applications.

7. The Deputy Inspectors of Schools are requested to submit to the District Educational Officer not later than the 15th May 1937 the lists for the different grades with their definite recommendations for selection or rejection together with the applications securely fastened with the relevant enclosures.

No'c.-(i) Applications not prepared in the prescribed form and filled in improperly will be rejected.

(ii) Only candidates who hold permanent appointments or whose entertainment after training is promised by the managements should be recommended for admission to training.

8. In the case of applications from deficient Secondary School Leaving Certificate holders for one year's training in the elementary higher grade, the instructions issued in Proceedings Dis. No. 70/33, dated 6th January 1933, of the Director of Public Instruction, Madras, should be carefully complied with.

9. Printed or cyclostyle application forms can be had from the offices of the Deputy Inspectors of Schools.
