TO AMEND THE ANGUL LAWS REGULATION, 1936

Preamble

WHEREAS it is expedient to amend the Angul Laws Regula-Orissa tion, 1936, for the purpose hereinafter appearing;

NOW, THEREFORE, the Governor of Orissa, in exercise of the powers conferred by sub-section (2) of section 92 of the Government of India Act, 1935, is pleased to make the following Regulation :-

Short title and commencement

Amendment of the Schedule to

Orissa Regulation V of 1936

- 1. (1) This Regulation may be called the Angul Laws (Amendment) Regulation, 1944.
 - (2) It shall come into force at once.

2. In Part II of the Schedule to the Angul Laws Regulation, Orissa 1936, the following amendments shall be made, namely :-

- (a) the entry "1913 VII The Indian Companies Act, 1913 The whole" shall be inserted immediately below the entry "1912 IV The Indian Lunaey Act, 1912 The whole except Chapter IV";
- (b) (i) the entry "1914 II The Destructive Insects and Pests Act, 1914 The whole" shall be inserted immediately below the entry "1913 VII The Indian Companies Act, 1913 The whole "
- (ii) in the entry "1914 III The Indian Copyright Act, 1914 The whole" the word "Ditto" shall be substituted for the words "The whole"; 6
- (c) the entry "1932 XIV The Indian Air Force Act, 1932 Ditto" shall be inserted immediately below the entry "1931 XXIII The Indian Press (Emergency Powers) Act, 1931 Ditto";
- (d) the entry "1934 XXXIV The Indian Navy (Discipline) Act, 1934 Ditto" shall be inserted immediately below the entry " 1934 XXV The Factories Act, 1934 The whole ".
