Subject.—Credits and remittances of subscriptions to the King-Emperor's Anti-Tuberculosis Fund.

SIR,

- (2) At the end of each week a voucher on a simple receipt should be drawn by the Treasury Officer or Sub-Treasury Officer, as the case may be, for the total amount of subscriptions received in the Treasury or Sub-Treasury during the week and paid by transfer credit to "Remittance Transfer Receipts" the number and date of the Remittance Transfer Receipt being quoted on the voucher as authority. The amount of the voucher should be debited to the deposit head mentioned above and the voucher submitted to this office along with the monthly treasury accounts.
- (3) A personal ledger account headed "Deposit on account of moneys received on account of the King-Emperor's Anti-Tuberculosis Fund" should be maintained in respect of the Fund in the Treasury and Sub-Treasury.
- (4) The rules for the maintenance of Personal Deposit Registers should be strictly observed. The necessary deposit returns (including plus and minus Memoranda) should be submitted to this office with the treasury accounts.
