✓ **No. 9793—4P-20/36-A.**—In exercise of the power conferred by sub-section (2) of section 13 of the Khondmals Laws Regulation, 1936 (IV of 1936), the Governor is pleased to confer upon the Court of the Subdivisional Officer, in addition to the powers specified in respect of such Court in column 1 of the table given in sub-section (1) of the said section, the following further powers, namely:—

(1) Powers corresponding to those of a Civil Court under the Code of Civil

Procedure, 1908 (IX of 1908), to try original civil suits of which the value exceeds Rs. 500 but does not exceed Rs. 3,000, provided that such suits are not in respect of revenue paying lands the value of the annual produce of which exceeds Rs. 500.

(2) Power to transfer to the Court of the Second Officer in the district of the Khondmals, suits in which any Zamindar, Bisoyee, or any Mansubdar, Muttadar or other feudal hill chief is concerned, if both parties desire such transfer or consent thereto and if the value of the suit does not exceed Rs. 500.

No. 9796—4P-20/36-A.—In exercise of the powers conferred by sections 10 and 12 of the Khondmals Laws Regulation, 1936 (IV of 1936), the Governor is pleased to direct, that in addition to the powers conferred in the Home, Revenue and Finance Department notification no. 349-A., dated the 26th May 1936, the Court of the Second Officer in the district of Khondmals shall have the powers corresponding to those of a civil court under the Code of Civil Proce-

dure, 1908 (IX of 1908), to try original civil suits of which the value does not exceed Rs. 500:

Provided that suits in which any Zamindar, Bisoyee, or any Mansubdar, Muttadar or other feudal hill chief is concerned shall not be tried in the court of the said Second Officer, unless such suits have been transferred to that court by the Subdivisional Officer in exercise of the power specified in notification no. 9793-A., dated the 30th December 1936.
