In the case of the successful bidders deposits will be retained as security for the due fulfilment of the lease conditions and may be adjusted towards the last instalment of the kist at the discretion of the Executive Engineer, Koraput Division and the balance refunded to the lessee at the expiry of lease period after satisfying all the lease conditions.

2. The Officer conducting the sale may, at his discretion, refuse to accept the bid of any person on the ground that he is insolvent or for any other valid reason.

3. The toll gate will be knocked down to the highest bidder, but the sale will be subject to confirmation by the Executive Engineer, Koraput Division, who may accept or reject any bid at his discretion without assigning any reason.

4. In the case of dispute during the time of sale, the Selling Officer's decision shall be final. If for any reason the highest bid is rejected the next higher shall be taken or the toll gate resold at the discretion of the Executive Engineer, Koraput Division.

5. The successful bidder shall pay the auction sale amount of the concerned toll gate in eleven equal monthly instalments on or before the 10th of every month beginning with 10th November 1945 to the Executive Engineer, Koraput Division, or to the concerned Sub-divisional Officer, Public Works Department, in cash or remit into the Government treasuries or sub-treasuries nearest to the toll gate to the credit of the Executive Engineer, Koraput Division, as "III—Other Remittances—Public Works Remittances" and the treasury chalan should be given to the concerned Subdivisional Officer, Public Works Department, on or before the 10th of every month in token of having remitted the respective amounts into the treasury on the due date.

6. The approved bidder shall, on receipt of confirmation of sale by the Executive Engineer, Koraput Division, execute an agreement in the prescribed form, copy thereof can be had in the office of the Executive Engineer, Koraput Division, or the concerned Subdivisional Officers and deliver it in the Office of the concerned Subdivisional Officers or in the Office of the Executive Engineer, Koraput Division on or before 30th September 1945, during office hours. The stamp duty on the agreement shall be borne by the lessee. The agreement need not be registered.

7. On the failure of the approved bidder to execute the necessary agreement by the stipulated time, the deposit already made may be forfeited and the toll gate resold or otherwise disposed of under the orders of the Executive Engineer, Koraput Division and the purchaser shall have no right of collecting any toll from the date of the Executive Engineer's order.

8. 1. 4. No toll shall be levied for the passage of carriage, cart or animals (a) conveying Police Officers on duty or persons or property in their custody, (b) licensed by the Executive Engineer during the period for which they have been so licensed.

5. The lessee shall not sell or transfer or sublet his toll gate or take in any other partner without the previous sanction of the Executive Engineer, Koraput Division.

6. In the event of the death of the lessee before the expiry of the lease, his legal heirs or assignees should, within two days after the death of the lessee, file a written statement for the continuation of the lease for the period of currency failing which it shall be open to the Executive Engineer, Koraput Division, to resell the toll gate or otherwise dispose it of at the lessee's risk and loss.

7. The lessee shall so arrange that passengers with their animals or conveyances are not unnecessarily delayed whether by day or night, but are allowed to pass through the toll gate without unreasonable delay on the tendering by them of the proper rate of toll in respect of animals or vehicles for which tolls are payable.

8. (i) The lessee shall make the following arrangements for the proper working of the toll gate. The lessee shall construct toll shed at his expense, at the places ordered by the concerned Subdivisional Officer, Public Works Department, at the site of the toll and check gates. He should also maintain the toll shed, barriers and notice board, etc., in proper order and keep the premises clean at his expense.

(ii) That a toll bar is placed in such a position as to be clearly seen at a distance of one hundred yards from both sides of the toll and check gates or at any suitable distance as directed by the Subdivisional Officer in writing.

(iii) That from sunrise to sunset a red flag and from sunset to sunrise two red lights visible on either side of the road, are fixed at the centre of such a toll bar.

Note—In the case of vehicles exempted from tolls no toll or check gate should be closed even temporarily causing inconvenience to the movement of such vehicles.

(iv) The lessee shall put up in a conspicuous place at the toll bar or gate or station and at his cost a table of tolls he is authorised to levy, legibly written or printed in

English and also in Oriya in words and figures. When such table is not put up at any toll bar or gate or station, no toll shall be leviable thereat during such time.

9. Not more than one payment of toll shall be demanded at the toll bar of a toll gate and its check gates, if any, or any other toll gate, in respect of any carriage, cart or animal in any one period of 24 hours counted from sunrise to sunrise.

Note—This rule is clearly not intended to cover extra trips by the same cart.

10. When payment of any toll is made, a receipt in the printed form shall be granted by the person to whom the payment is made failing which the lessee shall be liable to penalty in clause 16 below. Receipts shall be in the prescribed form, as per sample attached.

11. In case of non-payment of any such toll on demand the person duly authorised to collect the same may seize cart or animal in respect of which it is chargeable or any part of its burden and detain the same in his custody.

12. If any toll together with the expenses occasioned by such seizure and detention remains unpaid for twelve hours, the person duly authorized as aforesaid shall forthwith send the cart or other property seized as aforesaid to the nearest public officer empowered to sell distrained property under the Madras Rent and Revenue Sales Act, 1839.

13. The lessee may, subject to the approval of the Subdivisional Officer, Public Works Department, appoint proper persons, to collect tolls at the gates and shall furnish to the Subdivisional Officer a list showing the names and descriptions of persons so appointed by him. He should also similarly notify the changes in the list. In all cases of resistance to the lawful authority of the toll gate lessee or his employees in the realisation of authorised tolls, all police officers shall assist the lessee or his employees when required and for that purpose shall have the same power as they have in the exercise of ordinary police duties.

14. The lessee and all persons employed by him for the management of toll gates shall duly comply with any departmental orders and with any by-laws that may be framed by the Executive Engineer, Koraput Division and shall be subject to the penalties prescribed for any violation thereof.

15. Any sum due by the lessee may be collected as arrear of rent or adjusted from the deposit made by him at the commencement of the lease as the Executive Engineer, Koraput Division, may think fit. The lessee shall be bound to replace any sum adjusted from his deposit within 15 (fifteen) days of receipt of the notice from the Executive Engineer, Koraput Division.

16. Any wilful breach of the hereinbefore-mentioned conditions committed by the lessee or any of his employees or any irregularity or improper behaviour on the part of the lessee or his employees, shall render the lessee liable for each such breach, irregularity or impropriety to a fine not exceeding Rs. 50 (rupees fifty) or to the forfeiture of his deposit and lease, the toll gate being resold or otherwise disposed of at his risk and loss. The decision of the Executive Engineer, Koraput Division, shall in each such case be final.

17. The lessee must abide by the decision of the Chief Engineer, Orissa, in matters that are not specifically covered in the auction sale or lease conditions during the term of the lease.
