(2) The Government contractor should bay Mohua flowers from the Khonds and other hill men at the rates to be fixed by the District Forest Officer, Balliguda Division monthly or at shorter intervals as the market fluctuates.

(3) The contractor shall be bound to sell Mohua flowers at the maximum price fixed by the District Magistrate in exercise of the powers delegated to him under the Defence

of India Rules.

(4) The Mohua flowers imported into the Agency and covered by State export permits cannot be treated as produce of the Agency.

(5) The payment of purchase money will be made in full

or by instalments as detailed below :-

(a) Purchase price Rs. 500 or below:—
One instalment on or before the 1st May 1945:

(b) Purchase price above Rs. 500-1st instalment—50 per cent on or before the 1st May 1945, 2nd instalment—50 per cent on or before the 1st October 1945.
