TENDER DOCUMENT: 2 INFORMATION TO THE BIDDER

1. OBJECTIVE

Government of Odisha intends to hire the services of the Agencies for providing live common feed to Electronics and Social Media channels for wide publicity of various Developmental and welfare policies/schemes of the Government.

2. SCOPE OF WORK

Government of Odisha launching different welfare scheme for the benefits of the general public. Also organizing big events like Independence Day, Republic Day, Utkal Divas, Other National & State level events etc. To make the programmes more informative & effective, Information & Public Relations Department providing live common feed to electronics & social media channels for wide uniform publicity of launching of different schemes, plans, programmes & developmental activity of the Government by Hon'ble Chief Minister to creates wide awareness among the general public. Hon'ble Chief Minister attending some programmes in physical mode and some are in virtual mode.

3. **ELIGIBILITY CRITERIA**:

- The bidder must be a registered company under the Indian Companies Act or registered individual / partnership firm or Proprietorship firm/limited liability company.
- 2. The bidder should have valid GST registration for legally carrying out its business activities and also GST Registration Certificate with up-to date return filing copies.
- 3. The bidder should have a valid PAN. The bidder shall provide the details of the ownership of the company and Income Tax return filing copies for last three consecutive assessment year.
- 4. The bidder should have local office in the state of Odisha with adequate manpower and infrastructure support.
- 5. The bidder must have executed a minimum work like providing live common feed to electronics & social media channels of Rs. 3 lakhs during past one year and the bidder must furnish work order of the concerned organization.
- The bidder must submit annual turnover certificate of last three financial years duly certified by C.A. (indicating membership no. of C.A. with seal) ending on 31-03-2021 with audited balance sheet of last three financial years.
- 7. The bidder must not have been barred or blacklisted by any State/Central Government Departments or any PSUs.
- 8. The bidder with unsatisfactory performance, if any, will not be eligible for tender process.
- The agency should have own equipments. The equipments should have been manufactured within five years. An undertaking should be submitted by the bidder in this regard.

Terms and Conditions

The brief scope of works for providing multi camera for live common feed for telecast /webcast service under the contract is given below.

- 1) After completion of the programme, the agency must submit the GST bills/invoices along with the soft copies of the total live visuals (Rushes + Live programmes) in an external hard drive (In HD Format) to I&PR Department within seven days from the date of the programme.
- 2) The agency shall be intimated about the job viz. live common feed for telecast / webcast assignment etc. at a short notice within couple of hours.
- 3) The live common feed provided by the agency should be without any interruption, failure or glitches in the live transmission. Any deviation will attract penalty on the agency and payment will not be made.
- 4) No charges shall be paid to the agency, in case of cancellation of any live common feed by I&PR Department minimum 12 hours prior to the event up to 50 km distance from Bhubaneswar.
- 5) No charges shall be paid to the agency, in case of cancellation of any live common feed by I&PR. Department minimum 24 hours prior to the event beyond 50 km distance from Bhubaneswar.
- 6) Any supply of poor quality / downscaled video shall be summarily rejected and would be subject to non-payment and work will not be allotted for the next time.
- 7) All the visuals shall be treated as Government property (confidential) and should not be used by any unauthorized person / third party under any circumstances.
- 8) The agency should not sub-contract part or complete work undertaken by him without written permission of I&PR Department.
- 9) The agency should have minimum one year experience in the field of multi camera live common feed for telecast/ webcast service.
- 10) Bidders to ensure that their offers are complete in all respect. Any deviation (agency is found to be false) of non-compliance may lead to rejection of their offer at any stage.
- 11) The period of rate contract will be for one year from the date of assignment which can be extended upon mutual consent.
- 12) An undertaking is to be furnished that the firm is not black listed/debarred from any Govt. / PSU organization during recent past.
- 13) The agency should have own equipments. The equipments should have been manufactured within five years.
- 14) The rates quoted by the agency shall be excluding GST and taxes will be paid by the client as per the applicable rate under GST Act.
- Towards this end, Request for Proposal is invited from eligible Agencies fulfilling the laid down eligibility criteria to submit their proposals. The details relating to the eligibility criteria, terms and conditions and other information relating to this RFP can be downloaded from the Government of Odisha Portal:- http://www.odisha.gov.in and also from I&PR Website:- http://inpr.odisha.gov.in/. Tender shall be opened on dtd. 18.05.2022 at 11.00 AM in the Conference Hall of I&PR Department. Proposal may be submitted to the Director, I&PR Department in the address mentioned in the SI. No. 5 of the Bidder Data Sheet in a sealed envelope. The last date for receipt of proposals is on dtd. 17.05.2022 at 5.00 PM.

- 16) Wherever specific terms & conditions have not been spelt out in the document, OGFR of State Govt. shall apply.
- 17) Preference will be given to L-1 bidders for awarding the work to provide live Common Feed to different Electronics/Social Media channels for live coverage of different Government Programmes. Other technically qualified bidders shall be empanelled if they agree to execute the work as per the L-1 rates. The empanelled agencies will be entrusted with the excess work which is beyond the working capacity of L-1 bidder. The client reserves the right to distribute the work among empanelled agencies at different places of State as per requirement. The empanelment doesn't guarantee that the work will be provided to the firms empanelled.
- 18) All the crucial figures i.e. Rates & amount should be written in figures followed by words in a bracket in Tender documents.
- 19) There shall be no over-writing in the tender documents and other papers submitted. Any alteration should be initialled with seal by the same person who signs the Tender documents.
- 20) All the rates and amounts shall be quoted in Indian Rupees (INR).
- 21) Submission of more than one competitive bid by the same Firm in response to the same Tender call Notice is prohibited and both the bids shall be rejected.
- 22) No advance payment shall be made. Full payment will be made after receiving service from the firm and after certification given by the concerned Officer that full satisfactory service is received as per the specification of work order.
- 23) TDS under IT & GST shall be deducted as per law.
- 24) All the disputes shall be subjected to the jurisdiction of Civil Courts situated at Bhubaneswar.
- 25) Each page of this Tender Document should be signed by the bidder with seal in token of having read, understood and accepted the terms and conditions of this contract.
- 26) All the documents and papers submitted with the bid should be either in English or in Odia and shall be authenticated under the seal and signature of the bidder.
- 27) In case of any dispute/ambiguity arises in the documentation, decision of I&PR Department/Tender calling authority is final.
- 28) Beyond 50 km from Bhubaneswar transportation (Vehicle) may be allowed as per the Government approved rate/ OTDC rate on submission of GST bills/invoice within seven days from the date of programme. Use of number and type of vehicles will be decided by this Department.
- 29) Test run/Dry Run shall be done much before the programme starts to test all connectivity and equipments.

ELIGIBILITY CONDITIONS REQUIREMENTS

1.Bid Validity Period:

The Offer submitted and the prices quoted therein shall be valid for 90 days from the date of opening of Bid. Bid valid for any shorter period shall be rejected by the Client.

2.Bid Processing Fees:

The bidder must furnish as part of technical proposal, the required bid processing fees (Non-refundable) amounting to Rs. 5,000/- (Rupees Five Thousand) Only in shape of DD from any scheduled commercial bank in favour of "D.D.O., I&PR Department" payable at Bhubaneswar. Proposals received without bid processing fees will be out-rightly rejected.

3. Bid Security Declaration:

Bidder should submit "Bid Security Declaration" in lieu of Bid Security deposit with stipulation that if they withdraw or modify their bids/violates the terms and conditions of the Tender Documents during period of validity etc. and suspended for the period of three years from participating in any Government/PSU tenders.

4. Performance Security: The successful bidder shall have to enter into an agreement with the Tender Calling Authority for successful completion of the tender process for Live common feed within a week from the date of declaration of the successful bidder. In this regard the bidder has to furnish the security deposit to be called "Performance Security" amounting to Rs. 50,000/- (Rupees Fifty Thousand) only in the form of NSC / Post Office Savings Bank A/c / FDR from any nationalized bank/performance bank guarantee (PGB) duly pledged in favour of "D.D.O., I&PR Department" payable at Bhubaneswar. The "performance security" submitted by the bidder shall have to be valid till completion of the contract period.

5. Financial Evaluation: Least Cost Selection (LCS) method will be followed during the overall selection process. The client will select the lowest evaluated price bid among all the qualified bids. For the purpose of evaluation, the total evaluated cost shall be inclusive of all overhead expenses and applicable taxes for which the client makes payment to the agency. The successful bidder shall be selected taking into consideration of the lowest bid (L-1) in most transparent manner. The Tender Publishing Authority can negotiate the rates with the L-1 bidder and finalize the rates accordingly. The authority is not bound to accept the L-1 rates. If the L-1 bidder fails to sign the agreement then negotiations with Firms other than the (L-1) lowest bidder i.e. L-2 bidder shall be held obtaining prior approval of the Government.

6. <u>Termination of Contract</u>

The contract can be terminated by the Deptt. during the period of contract by giving 15 days notice in case of violation of any terms & conditions of the contract or in public interest. In case of violation of contract by the Company/Firm, the performance security can be forfeited by the Department towards levy of fine/ recovery and termination of contract including blacklisting the concerned Firm. In case the agency is not interested in continuing with the contract, he can give 2 (Two) month notice in advance citing reasons for the same.
